Thank you for your interest in becoming a PETS ARE WORTH SAVING (PAWS) foster caregiver. This program is a critical part of our mission to save dogs and cats from City shelters and we couldn't do it without assistance from you, the foster caregiver. You are saving the life of an animal that would otherwise be euthanized. A foster parent provides a temporary home for dogs and cats in need. The length of time that you will spend caring for the animal can vary depending on the amount of care needed to ready the animal for adoption and our ability place it in a permanent home.

To become a foster caregiver, you must:

- Be 21 years of age or older
- Be a permanent CA resident with identification confirming your correct address
- Be willing and able to provide the animal with the proper care it requires. This includes, but is not limited to, lots of love, attention, exercise, healthy nutrition and socialization

Completion of this application does not guarantee acceptance in the PAWS foster program. Review and approval of your application by a PAWS representative is required.
